Brief Session Description: The required instruction mandate (section 1003.42(2)(h), Florida Statutes) to teach African American history was passed in 1994, yet educators often struggle with instruction due to lack of knowledge or guidance on what and how to teach the subject matter. The Commissioner's African American History Task Force offers supports for educators and districts through their Exemplary Districts program and by providing resources, lesson plans, and professional development through workshops and a Summer Institute. Currently, 11 Florida school districts have received a designation of Exemplary from the Task Force. This session will focus on resources, strategies and opportunities for the educational enterprise in Florida, including the six criteria for an Exemplary District and how districts may fully engage in sharing the history and contributions of African Americans to the State of Florida and this nation.

Session Title: Turning Agony into Action – A father's journey to make schools safe after the Parkland shooting

Presenter: Max Schachter, Safe Schools for Alex, Founder and Executive Director

Session Description: Max Schachter is a national school safety advocate. His 14-year-old son Alex was one of the 17 innocent victims murdered in the Parkland school shooting on Valentine's Day 2018. Since the heartbreaking day that changed Max's life forever, he has been fighting for policy change at the highest levels of the United States government. Max has also worked to make Florida's schools safer. by serving as a commissioner on the Marjory Stoneman Douglas High School Public Safety Commission formed by former Governor Rick Scott. Through Safe Schools For Alex, the 501(c)(3) he created to honor Alex, Max provides the most current school safety leading practices to students, parents, school districts, and law enforcement so that all children can learn in a safe environment. During this presentation Max will demonstrate their latest initiative, the School Incident Report.

This free, user-friendly tool is the first statewide dashboard aimed at reducing violence and suspensions while also creating a positive culture and climate.
